- **Compactor enclosure including storage over sized items.**
- **Surveillance cameras at each entrance.**
- **Removed old non-functioning entrance gates**
- **Tennis Court resurfacing plus two benches for user comfort**
- **Our Fitness Center was brought to “state of the art” condition.**

- Implemented Power washing regiment on buildings & sidewalk etc.
- Installed additional benches at ponds.
- Bike Rack additions conveniently located at amenity centers.
- Updates to mail kiosks.
- Replace vent boots on the roof of all buildings.
- Initiated weekend Security for the summer months.

A huge, and particularly noteworthy,

accomplishment this year was the resurfacing too much of our parking areas and driveways.... Resulting from a coordinated effort between the original resurface company, (Duval Asphalt) , your Board, and KW Management, this resurfacing was accomplished with **ZERO** cost to the homeowners of Bishop's court. change. As we mentioned in a prior message, Bishop's Court will be taking over the collection of annual fees from our master Association, (Windsor Park). In the past, each homeowner was required to make payment to the Master Association (in full) in January of each year. Beginning January of 2019, your Master fees will be paid directly to Bishop's Court. ***This is as required by our governing documents.***

Here's the good news: Instead of having to write one check for the entire year, the annual Master fee will be divided into 12 equal payments and added to your monthly HOA fees. **Details forthcoming.**
